

California Redistricting Commission

It's 14 members will be setting the electoral districts for the next decade. But that won't happen unless pro-gun people like YOU get on the commission.

ANYONE can qualify for the commission.....unless you or a member of your immediate family has done any of the following:

- a) Been appointed to or been a candidate for federal or state office.
- b) Served as an officer, employee or paid consultant of a political party or of the campaign committee of a candidate for elective federal or state office.
- c) Served as an elected or appointed member of a political party central committee.
- d) Been a registered federal, state or local lobbyist.
- e) Served as a paid congressional, legislative or Board of Equalization staff member.
- f) Contributed \$2,000.00 or more to any congressional, state or local candidate for elective public office in any year.

THIS MEANS THAT MOST OF YOU CAN APPLY.

IT ALSO MEANS THAT A LOT OF ANTI-GUNNERS ARE GOING TO APPLY.

Members of the Commission will be selected based on the following timeline:

- a) Initial application **MUST** be received before Feb 12 2010.
- b) The first batch of applicants will be screened.
- c) Those that pass the first screening **MUST THEN SUBMIT A SECOND APPLCIATION** and it must be received **BEFORE** April 12 2010.
- d) The Applicant Review Board (ARB) will then submit each of the top 120 qualified applicants to a series of screenings and interviews. Sometime before Dec. 20 2010 the State Auditor randomly selects the first 8 commissioners. These first 8 commissioners then select the remaining 6 members.

And that's when the fun starts. **YOU** get to make things fair again so that pro-gun candidates actually have a chance of winning an election. **NO MORE ANTI-GUN** politicians ramming one bill after another down our throats.
