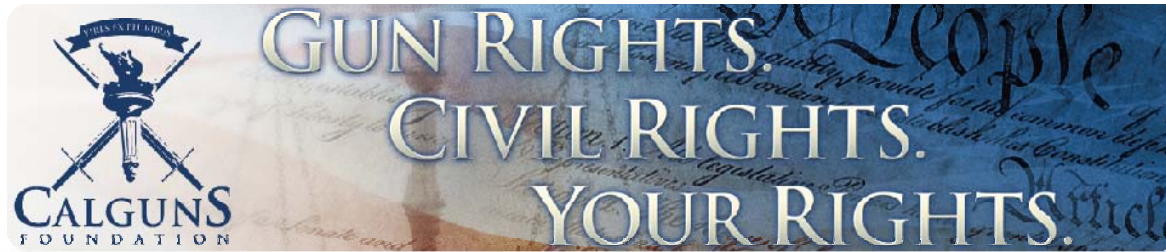

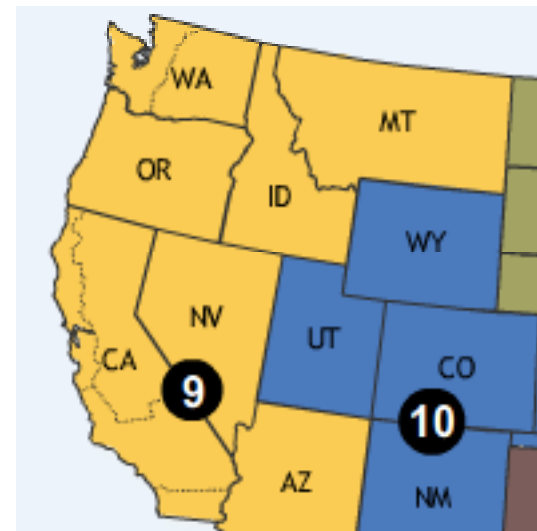
Nationwide Carry Strategy

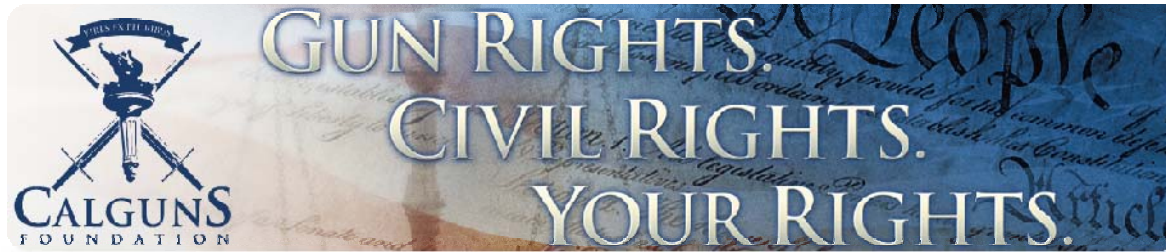

OOIDA/AB-962

- Penal Code §12318
 - “Commencing February 1, 2011, the **delivery** or transfer of ownership of handgun ammunition may only occur in face- to-face transactions with the deliverer or transferor being provided bona fide evidence of **identity from the purchaser** or other transferee. A violation of this section is a misdemeanor.”
